## **Scope of the work:**

The Lawrence School, Lovedale, Ooty, Tamilnadu (hereinafter referred to as the "LSL/School"), an Educational Institution, invites NIT(s) for Supply, Installation, Testing, Commissioning, and Maintenance of the CBSE-Aligned Digital SmartClass Content Solution (Grades 5–12) (as per Annexure-II) for The Lawrence School in its permanent campus at Lovedale as per the NIT document.

### Objective

To implement a robust and interactive Digital SmartClass Content Solution for students of Classes 5 to 12, aligned with the latest **CBSE curriculum and NCERT textbooks**, aimed at enriching the teaching-learning process through technology-enhanced educational content.

#### Deliverables

### **Eligibility Criteria for the Service Provider (SP):**

All the Vendors/Service Provider must fulfil the following eligibility criteria and submit the documents and the declarations (duly self-attested) in support of their claim along with the NIT. The applications of those not meeting the Eligibility Criteria stated below and not accompanied with the requisite documents will be treated as incomplete and hence be rejected.

- i. Must be a registered entity under the Indian Companies Act, LLP Act, or Partnership Act.

- vi. **Document:** Client list with contact details
- vii. **Content Alignment:** Must provide digital content strictly aligned with NCERT textbooks and CBSE syllabus for Classes 5–12, available in English and optionally in Hindi.
- viii. **Document:** Sample content demo links, chapter mapping
- ix. **Technical Capability:** Must offer a robust content delivery platform supporting offline/online access, interactive boards, and multiple user logins.

- xi. Must provide training for teachers and ongoing technical/content support.

#### **Contract Period**

The Contract shall initially be valid for a period of **Three (3) years** and may be extended on **year-to-year basis** for further **two years period** based on satisfactory performance and with mutual consent and rates, terms & conditions mutually agreed at the time of extension.

## **Support & Maintenance**

The Service Provider shall offer end-to-end support and maintenance services for a minimum period of **three (3) years** from the date of commissioning of the Digital SmartClass Content Solution, with the objective of ensuring uninterrupted, secure, and optimal performance of the content delivery platform, software, and associated classroom integration.

## **Evaluation of NIT**

- The NIT will be evaluated based on the rate list quoted in **Annexure–II**. The rate list of any Vendor/Supplier who does not fulfill the **Eligibility Criteria** shall be rejected.
- **Selection of Vendor:** Only those vendors who qualify in the **Technical Evaluation** shall be considered for evaluation of commercial bids.
- The procurement will be conducted in accordance with the General Financial Rules (GFR)
  - Quality-cum-Cost Based System (QCBS) guidelines.

#### **Evaluation and Procurement Process:**

An open tender will be published on the School's official website to invite quotations.

#### **Technical Bid:**

- Vendors must provide a live demonstration of their Digital SmartClass Content Solution to the Technical Evaluation Committee.
- The technical evaluation of the bids will be conducted first by the Technical Evaluation
   Committee members as per GFR QCBS norms.

#### **Technical Functional Evaluation Framework**

The bid response of the SI /Bidder that qualify as per the Pre-Qualification criteria, would be evaluated based on the following Technical Functional Evaluation framework:

The minimum qualifying mark for the technical functional evaluation is 70 out of a total of 100 marks as per the evaluation criteria listed above and denoted by Ts.

As an Example, the following procedure will be followed:

Overall Score (OS) of a bidder will be his Technical Score (TS) plus his Financial Score (FS) and will be evaluated as under:

## Overall Score = Technical Score (TS) \*0.7 + Financial Score (FS)\*0.3

A maximum of 100 marks will be allocated for the Technical Bid. Technical bid will be evaluated as per the technical bid evaluation table shown in above table with this RFP.

Technical Score of a bidder will be evaluated as under:

#### Technical Score = (Bidder's Technical Score/Highest Technical Score)\*100

Where TBV stands for Technical Bid Value of a bidder. Financial bid will be evaluated as under:

## Financial Score = Lowest Financial Bid Value(LFBV)/ Financial Bid Value(FBV) × 100

Where LFBV stands for Lowest Financial Bid Value and FBV stands for Financial Bid Value of the concerned bidder.

#### **Financial Bid:**

- After the technical evaluation, the Financial Bids of only technically qualified vendors will be opened by the Purchase Committee.
- The selection will be based on the Quality-cum-Cost Based System (QCBS) with 70%
   weightage for the Technical Evaluation and 30% weightage for the Financial Bid.
- Negotiations, if required, will be conducted only with the L1 vendor, subject to approval by the competent authority.

A Committee constituted by the School shall evaluate the tenders. The decision of the Committee in the evaluation of the NIT shall be final, and no correspondence will be entertained outside the process of negotiation/discussion with the Committee.

Any attempt by the Vendor/Supplier or their representatives to influence the decision on the NIT, officially or otherwise, shall result in the NIT being summarily rejected. The Committee is fully empowered to take the final decision regarding the NIT.

#### 2. Security Deposit: (Applicable for the successful bidders)

i. The Vendor/Service Provider shall be required to submit the Security Deposit (SD) for an amount of ₹25,000/- (Rupees Twenty Five Thousand only) before finalization of the contract. - iii. SD is not exempted to any Organizations/Institutions/Communities/Society/ Voluntary organization, etc.
- iv. Vendor/Service Provider whose SD is already with the School need not to pay SD again.

- v. Security deposit of the successful Vendor/Service Provider shall be forfeited, if he/she refuses or neglects to execute the order within the time frame as specified by the School.

#### 3. Allotment of Contract:

#### 4. **Termination of Contract:**

- i. The School is at liberty to terminate the Contract with one-month notice, without assigning any reasons.
- ii. If even after award of contract, the information/facts submitted by the Vendor/Supplier are found misleading/incorrect/false etc., The Headmaster of The Lawrence School, Lovedale, reserves the right to terminate the contract.

- iv. The Headmaster, The Lawrence School, Lovedale, shall have the right to terminate the contract, by giving 30 days' notice, if in his opinion the quality of services offered is not up to the standard/satisfactory.

#### **GENERAL TERMS AND CONDITIONS OF CONTRACT:**

- 1. The contract will be for a period of one year, or a period that is on mutual agreement, commencing from the date of signing the contract.
- 2. In case of any dispute between the successful Vendor/Supplier and its employee, The Lawrence School, Lovedale will have no responsibility and shall not be responsible for

any compensation in any form to such employment to any of such employees during or after the expiry of this agreement.

- 3. The successful Vendor/Supplier will have to provide good quality and standard product of items to The Lawrence School, Lovedale, as specified in Annexure-II.
- 4. The successful vendor /supplier will ensure compliance of all the relevant provisions of the Laws / terms of contract.
- 5. The successful Vendor/Supplier shall not do anything inside or outside the premises, which may create nuisance or any cause of annoyance to the students, working staff or to the visitors visiting the premises.
- 6. These are only proposed draft terms & conditions and can be modified/changed or added at the time of finalization and signing the agreement.
- 7. Conditional/Incomplete offers not conforming to tender document will be rejected.
- 8. If the Vendor/Supplier is a partnership of two or more persons all such persons shall be jointly and severally liable to the School for the fulfillment of the terms of contract.
- 9. The Vendor/Supplier will be held wholly responsible for any action taken by statutory bodies for violation /non compliance of any such provision/rule.

- 13. The Vendor/Supplier shall be governed by and interpreted in accordance with laws of India for the time being in force.

#### **Payment Terms: -**

The payment for the **Digital SmartClass Content Solution (Grades 5–12)** service shall be made in **Twelve (12) equal quarterly installments**. An **advance payment** will be released at the **beginning of each quarter**, subject to the following condition:
