A separate **Work Order** shall be issued for the **installation charges**, in addition to the supply order, as per the approved terms and conditions.

### **Special Conditions:**

**Complete Responsibility of the Bidder:** The bidder shall be fully responsible for supplying, installing, configuring, and commissioning the complete RFID-Based Asset Tracking System. The School **will not provide any manpower** for installation or tagging work. The work must be carried out entirely by the bidder's team, under the supervision of the School.

#### **RFID System Installation & Configuration**

Install and configure the RFID Asset Management Software.

Configure and deploy handheld RFID readers.

Ensure full integration between hardware (tags, readers) and the software platform.

Set up RFID tag encoding, mapping, and asset association within the school's digital asset database.

**Delivery & Completion Timeline:** Delivery of all RFID equipment must be completed within 15 days from the date of Purchase Order (PO). Complete installation, tagging, configuration, and commissioning within **90 days** at The Lawrence School, Lovedale.

It is advisable that the bidder deploy adequate manpower to ensure timely completion of the project.

**Accommodation & Logistics:** The School will provide one room for accommodation of the installation team. Food will be provided only during school term time. The vendor shall bear all expenses related to accommodation and other logistics.

The Work Completion Certificate shall be issued only after successful completion of all works in every respect, strictly as per the terms and conditions of the NIT, and to the entire satisfaction of LSL.

The quoted prices should be inclusive of all applicable taxes (including GST), duties, freight, insurance, installation, and any other charges up to delivery and installation at The Lawrence School, Lovedale. The quote validity must be for a period of 45 days.

#### **Training**

Upon completion of installation and commissioning, the Successful Bidder shall provide hands-on training to the concerned officials of LSL on the installed equipment. Training materials/manuals for the equipment shall also be provided.

#### **Warranty Period**

- All equipment, including active and passive components supplied under this NIT, shall carry a
  comprehensive warranty for a period of three (3) years from the date of installation and
  commissioning.
- During the warranty period, the Successful Bidder shall provide all relevant firmware, operating system updates, and security patches released by the OEM at no additional cost to LSL.
- The vendor shall act as the liaison on behalf of LSL with OEMs for repair or replacement of equipment and accessories covered under warranty.

#### **Annual Maintenance**

After expiry of the warranty period, the Annual Maintenance of the entire system shall be undertaken as per the terms and conditions stipulated in the tender, or any other conditions mutually agreed with LSL.

#### **Security Deposit**

The Successful Bidder shall deposit **10**% **of the total work order value** towards Security Deposit in the form of a Demand Draft or Bank Guarantee, drawn in favour of "**Headmaster**, **The Lawrence School**, **Lovedale**", payable at Lovedale.

The Security Deposit will be released within three (3) months after expiry of the one-year warranty period, subject to satisfactory performance.

All prospective vendors are required to conduct a site visit prior to submission of their quotation to obtain any necessary clarifications. Please note that once submitted, the quoted price shall be considered final and no revision will be permitted after the award of the contract.
