To ensure a transparent and reliable selection process, the following criteria will be followed while awarding the Bursary Scholarship to eligible candidates.

CRITERIA:

a) Family has gross annual income below Rs.8 lakhs from all sources.

- b) Persons whose family owns/possesses the following assets shall be excluded from the Bursary Scheme:
 - i) 5 acres of Agricultural land and above;

ii) Residential Flat of 1000 sq. ft. and above;

iii) Residential Plot of 100 sq. yards and above in notified municipalities;

- iv) Residential Plot of 200 sq. yards and above in areas other than the notified municipalities.
- c) The property held by family in different locations/places will be clubbed while applying the land and property test to determine Bursary Status.
- d) Income & Asset certificate (Annexure II) duly certified by any one of the following authorities should be appended with the application:
- i) DM/ADM/Collector/Dy. Commissioner/Additional Dy. Commissioner/1 Class Stipendiary Magistrate/SDM/Taluk Magistrate/Executive Commissioner, Magistrate/Extra Asst.
- ii) Chief Presidency Magistrate/Additional Chief Presidency Magistrate;
 - iii) Revenue Officer not below the rank of Tehsildar;
 - iv) Sub Divisional Officer of the area where the applicant/his family resides.
- e) The term "Family" for this purpose will include the person who seek the benefit of Bursary Scheme, his/her parents & siblings below the age of 18 years and also him/her spouse and children below the age of 18.

Eligible persons who wish to avail the benefit of the Bursary Scholarship Scheme may submit the duly filled Application (Annexure 1) along with Income & Asset Certificate (Annexure II) to the following address through Registered Post/Courier so as to reach on or before 31st July, 2025
